# 1. General description

The 74LVC32A is a quad 2-input OR gate. Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V environments.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

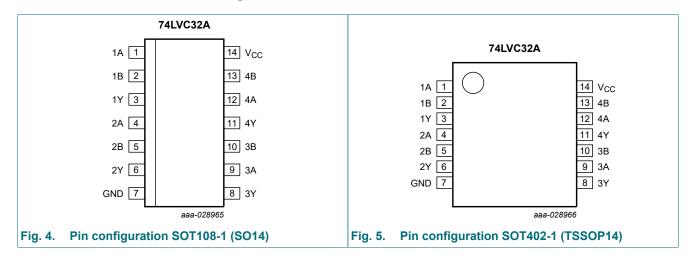

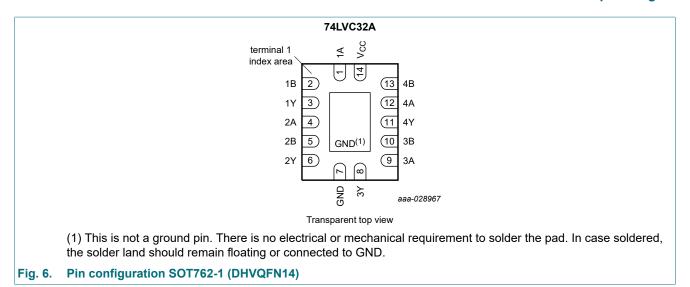

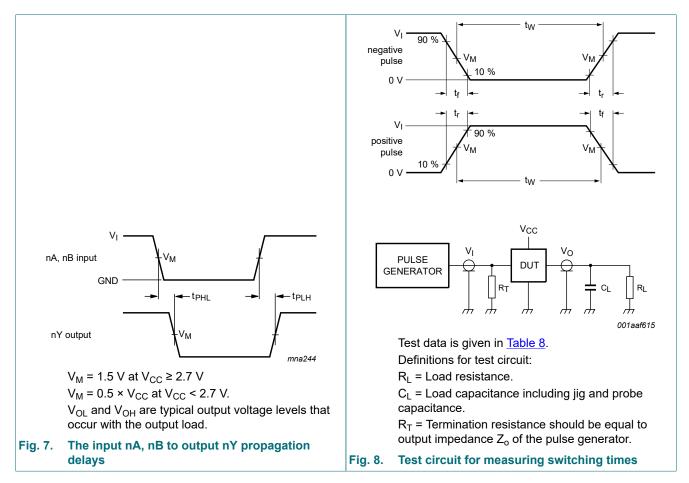


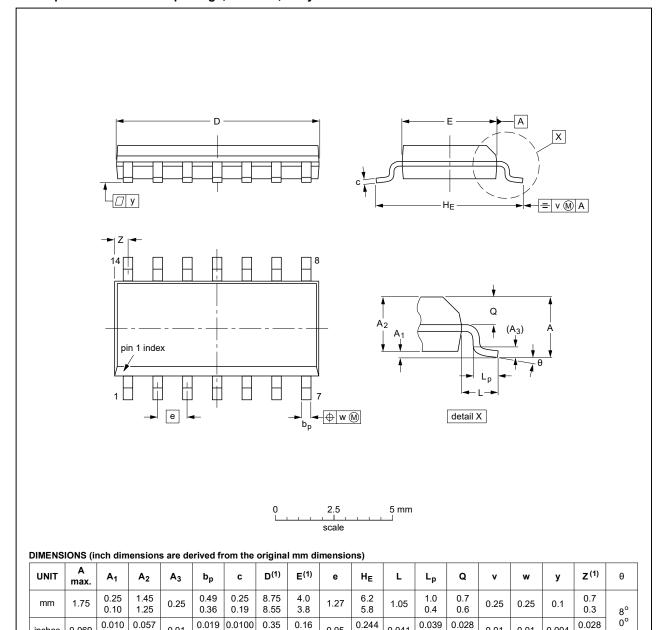

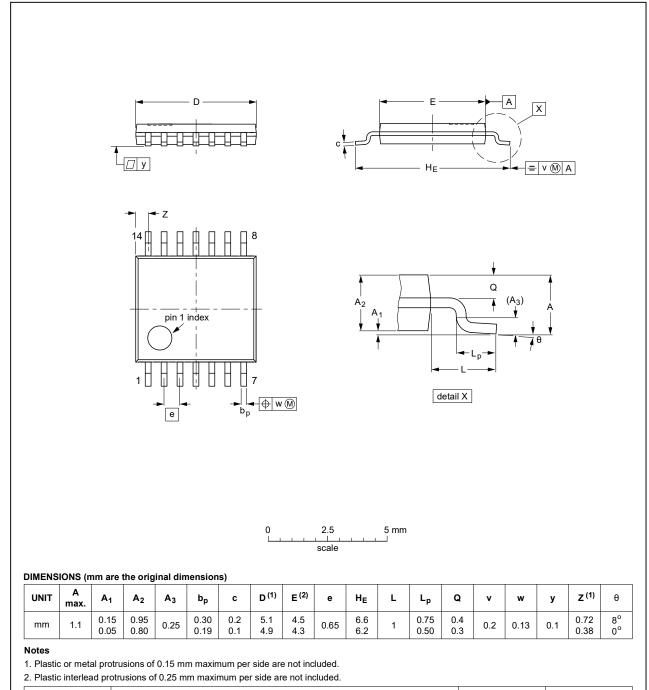

Fig. 10. Package outline SOT402-1 (TSSOP14)

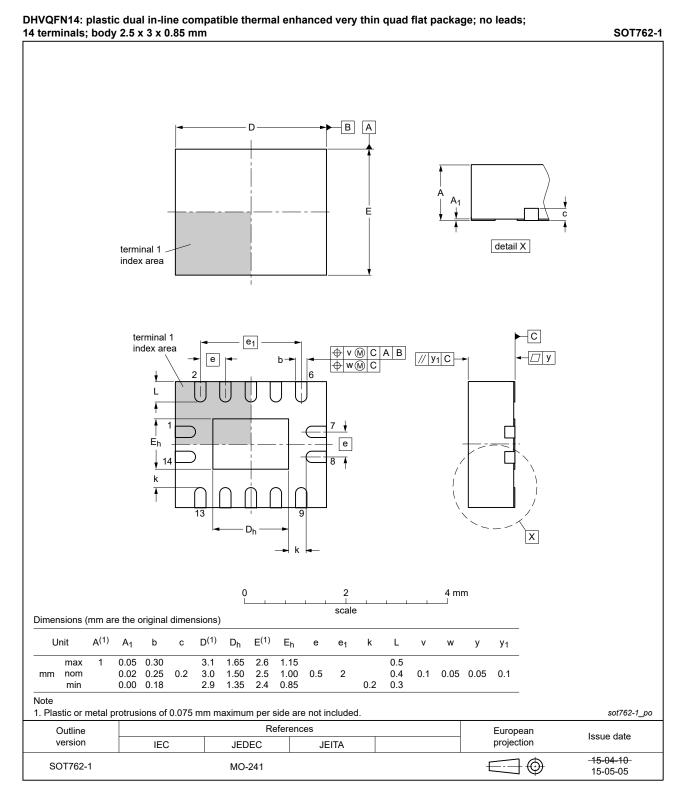


Fig. 11. Package outline SOT762-1 (DHVQFN14)
